**Harbor Creek Little Gridders
Agreement to Borrow Football Equipment**

I understand that it is my responsibility to pick up the Equipment and return it to the same location at the end of my rental period unless otherwise agreed by both parties. I agree to return the Equipment to Harbor Creek Little Gridders in the same condition that it was in on the day I borrowed it with normal wear and tear being accepted. The Equipment is not permitted to be used anywhere except Harbor Creek Little Gridders sanctioned practices or games.

I understand that there is no charge for the use of the Equipment. However, in the event that the Equipment is lost or destroyed during my rental period, or if the Equipment is not returned within 15 days after my rental period, I authorize Harbor Creek Little Gridders to charge my credit card, as described below. My credit card is not authorized for any other purpose other than to pay for Equipment.

Release and Waiver of Liability

Harbor Creek Little Gridders 2017 Tackle Football

Name of Participant (please print) _____ (the "Participant").

The Participant desires to participate in the Harbor Creek Little Gridders 2017 tackle football program.

In consideration of the Participant being permitted to participate on the team and its activities, the Participant and Parent/Legal Guardian executing below (together, the "undersigned") hereby release and forever discharge the League, Harbor Creek Little Gridders and their respective affiliates, officers, managers, members, directors, agents, employees, contractors, heirs, personal representatives, executors, successors and assigns, and anyone else acting on their behalf (individually, a "Released Party" and collectively, the "Released Parties") from any and all liabilities, claims, demands or actions for personal injury (including death), illness, accident, property damage or any other loss, damage, injury, judgment, cost or expense resulting directly or indirectly from any act or failure to act, including negligence or gross negligence by or on the part of the Released Parties, which may in any way arise out of the Participant's participation on the team and its activities.

The undersigned understand and acknowledge that the Participant's participation on the team and its activities is completely voluntary and at his/her own risk and that none of Harbor Creek Little Gridders, or any other Released Party is requiring the Participant to participate on the team or its activities. The undersigned also understand and acknowledge that the Participant will engage on the team and its activities at his/her own risk and that his/her participation on the team and its activities, may expose him/her to certain known, unknown and unanticipated hazards, risks and dangers associated with the team and its activities, including, but not limited to, personal injury, illness and loss or damage to personal property, and the undersigned specifically waive any and all claims against the Released Parties arising out of such conditions and/or the League and its activities. The Released Parties do not own or control the premises on which the team activities are taking place or any vehicle used to provide transportation or any driver of such vehicle. The Released Parties have not made, and do not make any warranties or representations with respect to such premises or any such vehicle or the condition thereof or the driver of any such vehicle. The Participant agrees to follow the rules and regulations of the team, as such rules and regulations exist from time to time. The undersigned understand that the Released Parties shall be entitled to limit and/or prohibit the Participant's participation on the team if he/she violates the rules or regulations of the team or any Transportation used by the Participant.

The undersigned understands and acknowledges that the team may not have the medical staff of resources available during its activities to store or administer prescription or non-prescription medications for the Participant or to otherwise treat any medical condition (known or unknown) of the Participant. The undersigned have decided that the Participant is capable of taking his/her own medication(s) while participating in the activities of the team. The undersigned understands

and acknowledges that the team staff will not store or administer medications, prescription or non-prescription, for the Participant during team activities. If the undersigned decides that the Participant can take his own medication during the team activities, the undersigned Parent/Legal Guardian will make arrangements as needed to remind the Participant to take his medication. If the Participant possesses any medications (prescription or non-prescription) during the team activities, the undersigned understands and acknowledges that it will be the Participant's sole responsibility to safeguard and self-administer the medication at all times. No Released Party will be responsible for lost or stolen medication(s).

The undersigned hereby authorize the team and its staff, employees, agents and contractors to obtain or administer any medical care or treatment deemed necessary if the Participant suffers any injury, illness or other medical condition while he is participating on the team or its activities.

The undersigned fully recognize that if the Participant suffers any injury (including death), illness or accident or suffers any other loss as a result of participating on the team and its activities, neither the Participant nor his family or any of their heirs, personal representatives, executors, successors or assigns will have any right to make any claim or file any lawsuit of cause of action against the Released Parties.

The undersigned hereby authorize Harbor Creek Little Gridders to use for any lawful purpose any video or photos of the Participant taken during the team activities (the "Photos"). The undersigned give and release to Harbor Creek Little Gridders, without compensation (a) any and all rights that the undersigned might have now and forever in the Photos, including any copyrights; (b) permission to reproduce, distribute and display the Photos to the public (including display on the Harbor Creek Little Gridders website); and (c) permission to prepare other works for distribution for any lawful purpose (such as promotional materials, annual reports or advertising) based upon or using the Photos.

The Release and Waiver of Liability shall be governed by the laws of the Commonwealth of Pennsylvania. The undersigned expressly agree that this Release and Waiver of Liability is intended to be broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania and that if any portion hereof is held invalid, it is agreed that the balance hereof shall continue in full legal force and effect.
