



# HARBORCREEK TOWNSHIP

## Summary Of Parks Rules and Regulations

### **Section 1: Authority**

The authority to make and enforce these rules is granted through Township Ordinance's #79-79 and #95-164.

### **Section 2: Hours of Operation**

Township parks open at 9:00am and closes at 9:00pm.

In the event of hazardous conditions (weather, etc.) endangering property of park may be closed at the discretion of the Township Parks Superintendent.

### **Section 3: Rental of Picnic Pavilions**

Applications must be completed with rental fee and required security deposit for use of picnic pavilions.

Picnics are permitted only in locations stated on the reservation form. The reservation fee entitles your group exclusive use of the designated picnic shelter, but **NOT** the entire park area. Visitors will **NOT** trespass on private property surrounding the park's limits.

ABSOLUTELY NO open fire grills or fryers to be under pavilion roof and/or in the kitchen area, placed on any concrete or asphalt surface. Fires may NOT be built or allowed anywhere in the Park; other than in stoves and/or grills provided for that purpose and located by the Parks Board and/or Parks Department.

Do not dump any grease, oils, or food in sinks.

Do NOT move tables from under the pavilion roof. Any other tables moved are to be placed back in the original location. Shades Beach (applicable), stainless steel tables are NOT to be removed from the kitchen.

Only ONE appliance (roaster, slow cooker, crock pot, etc.) per GFC outlet. Overloading outlets with appliances will cause power failure. Please review to each pavilion for specific instructions.

Persons holding picnics shall clean up and place all paper and other refuse, including cigarettes in receptacles provided for that purpose.

Any group of 25 or more persons using park facilities **MUST** obtain permission at least seven (7) days in advance.

Parties consisting of 200 people or more must provide a parking lot attendant.

### **Section 4: Activities Prohibited or Restricted**

Grass areas must not be used for roadway parking or other purposes, which may injure the turf or landscaping.

Trees, shrubs, hedges, wildflowers or other flowers, must not be picked, dug, broken, or injured in any way whatsoever.

Buildings, fences, fountains, benches, walls, posts, or signs must not be injured, defaced, or removed from the park or immediate location. ABSOLUTELY NO tacks, nails, staples, or tape on ANY wood surface. Eyelets on pillars are to be used for banners, balloons, etc.

No person shall conduct himself/herself within the Park so as to harass or annoy any other person using the Park for recreational purposes.

No littering or property damage.

Public meetings, camping, assemblages, or parades may not take place within the Park limits without written consent of Parks Superintendent. This includes any organized group conducting activities of any kind within the Park areas.

Inflatables, wall climbers, etc. are NOT permitted.

### **Section 5: Restrictions of Pets**

*Shades Beach and Whitford Park*; No domesticated animals are permitted on property at any time.

*Project 70*; Domesticated animals are allowed on paved walkway ONLY.

**Section 6: Motor Vehicles**

The parking of vehicles is prohibited in areas other than the designated parking lots. No parking permitted on highway berms and inside driveway chains.

Vehicles inside for unloading and drop-off and pick-up of handicapped and elderly visitors allowed.

ALL VEHICLES must return to the designated parking lot.

NO vehicles on grass areas.

A rate of speed exceeding 15 miles per hour is prohibited in the Park.

**NO EXCEPTIONS to RULES  
VIOLATORS SUBJECT TO REMOVAL FROM PARK**

Failure to adhere to Park Rules may result in forfeit of security deposit and/or additional charges for damages of property.
